Sub: Grant of Provisional recognition to the school upto secondary level(without aid) with effect from academic session 2005-06 for a day school.

Sir,

With reference to your application on the subject cited above. I am directed, to convey the approval of the appropriate authority for grant of provisional recognition in respect of your school from Ist to Xth standard with effect from academic session 2005-06 (without aid) under Rule 52 of D.S.E.Act & Rules 1973 subject to the fulfillment of the following terms and conditions:-

1. That school shall abide by the provisions of Delhi School Education Act and Rules,1973 and the instructions issued from time to time.
2. That school shall appoint full time qualified and eligible staff as per the norms of the Department. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
3. That all the facilities prescribed under Rule 50 and 51 of Delhi School Education Rules,1973 shall be made available to the students. Provisions of Rules 6,7 & 8 be strictly observed.
4. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student may be added and facilities of reading room may also be provided immediately and more books worth Rs.5000/- be purchase by the start of next academic session and the list of books be furnished to the Education Officer for verification.
5. Adequate sports material shall be purchased and made available to the students immediately.
6. That the school shall equip the Science Lab. as per the norms of the Department and suitable facilities for practical work shall be provided to the students. More material worth Rs.5000/- shall be purchased during the current session and a list be furnished to the Education Officer for verification.
7. That the school shall admit student without any discrimination of caste and creed as per the norms of the Deptt.
8. That the payment shall be made as per provisions of Section 10(1) of Delhi School Education Act,1973 to all employees. The staff should be paid full salary with allowance through cross cheque before 7th of every month.
9. That the arrangement of good drinking water shall be made available to all the students/teachers and sanitary facilities shall also be provided to the students immediately.
10. Health certificate shall be submitted to the Education Officer for verification.

11. That the enrolment in each section shall not exceed the number of students calculated @12 sq.ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Dte. Of Education, Delhi in each class. Number of existing sections should not exceed the number of class room of proper size in the school.
12. That Govt. nominee in the managing committee will be asked immediately and all decisions will be taken in accordance with the provisions of the scheme of management submitted to the Director of Education, Delhi .
13. That the Managing Committee of the school shall not enhance the fee during the ensuing academic session without the pre approval of the Directorate of Education which is a mandatory requirement under sub-section (3) of Section 17 of Delhi School Education Act,1973 and shall regulate the functions of the school strictly in accordance with the provisions of the Act and rules.
14. That the violation of any instructions/orders/conditions/rules and regulations of the Deptt. shall lead to the withdrawal of recognition of the school.
15. That a report about the fulfillment of the conditions giving the extent to which each condition is fulfilled shall be sent to the Education Officer within six month.
16. This is however subject to outcome of the court in WA 511/03 in the Hon'ble High Court of Delhi . ^{case}
17. This is subject to the submission of Building Completion Certificate from the Competent authority on or before 31.3.2006.
18. As per the norms of the Department , the school will admit 20% students from BPL category and will intimate to the Department every year accordingly.
19. The school will open a FDR A/c in the joint name of D.D.E equal to three months salary of the staff.
